Clinical Research

Pharmaceutical Industry

- Attend national congresses and investigator meetings to maintain client relationships and obtain current scientific information
- Develop and/or deliver scientific presentations on assigned therapeutic area or clinical research studies
- Meet with various medical science liaisons, medical directors, and medical affairs teams from various pharmaceutical companies

Academic/Preceptorship

- Educate and precept advanced pharmacy students in both the didactic and clinical settings from various Colleges of Pharmacy
- Evaluate and review relevant medical literature to write, review, edit, and publish book chapters, review articles, and/or original research manuscripts
- Obtain teaching certificates through University of Florida

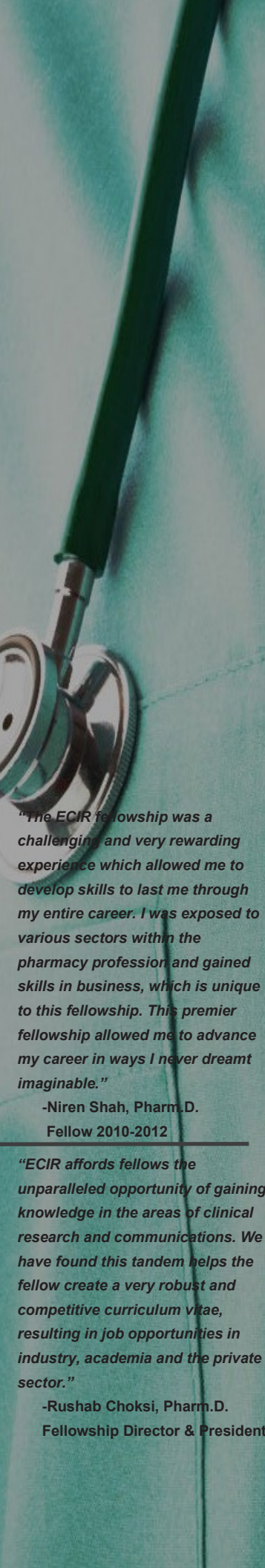
